This two volume publication describes and documents past efforts to establish an international criminal court and illustrates why such a tribunal would help to deter international crimes and thereby serve the cause of world peace.
- Basic Problems in International Fiscal Law. Knechtle, Arnold. Dewenter: Kluwer, 1979. Pp. xx, 264. Paper. This book reduces the study of international fiscal law into clear cut principles and specifically examines the causation, forms and modes of elimination of double taxation.
- Comparative Regional Systems: West and East Europe, North America, the Middle East and Developing Countries. Feld, Werner J. and Boyd, Gavin, eds. New York: Pergamon Press, 1980. Pp. vii, 530. Cloth. A collection of essays dealing with the patterned and unpatterned forms of international activity through which states relate to their neighbors.
- Control of Sea Resources by Semi-Autonomous States: Prevailing Legal Relationships Between Metropolitan Governments and Their Overseas Commonwealths, Associated States, and Self-Governing Dependencies. Franck, Thomas M. Washington: Carnegie Endowment for International Peace, 1978. Pp. vi, 37. Paper. Results of 1977 conference regarding relationship between phenomenon of newly declared two hundred mile exclusive seaward economic zones and the nature and jurisdictional status of special relationships between metropowers and a number of associated states and overseas territories.
- Government Controlled Enterprises: International Strategic and Policy Decisions. Mazzolini, Renato. New York: Wiley, 1979. Pp. xxiv, 400. Cloth. This book analyzes how European government controlled enterprises make strategic and policy decisions, with special focus on their international operations.
- Immigration Law and Practice. Wasserman, Jack. Philadelphia: Joint Committee on Continuing Legal Education of the American Law Institute and the American Bar Association, 1979. Pp. xxi, 180. Cloth. A comprehensive overview and discussion of visa and admissions procedures and exclusion and deportation practices, in-

cluding judicial review and rights and responsibilities of aliens in the United States.

- International Control of Marine Pollution. Timagenis, Gregorios J. Dobbs Ferry, New York: Oceana Publications, 1980. Pp. 1vii, 877. Cloth. This two volume collection provides a brief review of past conventions on marine pollution, an examination of emerging principles of the law of marine pollution and a review of the results of the United Nations Conference on Human Environment and Marine Pollution.
- International Norms and National Policy. Bonkovsky, Frederick O. Grand Rapids: Eerdmans Publishing Co., 1980. Pp. xiii, 220. Paper. A comprehensive study of the theories of international politics, from their ancient Greek origin, through formulations of Augustine and Grotius and into the present.
- Legal Aspects of Doing Business in Latin America: Mexico, Brazil, Argentina, Chile, and the Andean Common Market Countries. New York: Practicing Law Institute, 1980. Pp. 296. Paper. Educational supplement to program entailing United States income tax considerations, the legal nature of business organizations in Latin America and dispute settlement.
- New Economic Order and International Development Law. Rivero, B., Oswaldo de. New York: Pergamon Press, 1980. Pp. xvi, 141. Cloth. An enlightened exposition of the complex problems associated with the search by the international community for a new economic order and its treatment of various processes by which international economic relations might be brought closer to the realities of interdependence.
- Political Parties in the European Community. Henig, Stanley, ed. London: Allen & Unwin, 1979. Pp. 314. Cloth. A collection of essays dealing with the operation of the party system and the functioning of parties in the nine member countries of the European community.
- Restraints on War: Studies in the Limitation of Armed Conflict. Howard, Michael, ed. Oxford: Oxford University Press, 1979. Pp. vii, 173. Cloth. Essays concerning the restraints on war pre-1945, the limited conventional war in the Nuclear Age and wars of national liberation.
- Slave Trade Today: American Exploitation of Illegal Aliens. Lewis, Sasha Gregory. Boston: Beacon Press, 1979. Pp. xi, 239. Cloth. An examination of the illegal labor force in America today includ-

ing specific discussions regarding the entry of illegal aliens, jobs available in the United States, and a possible resolution of the problems resulting from the existence of such an illegal labor force.

- Trade, Taxes, and Transnationals: International Economic Decision Making in Congress. New York: Praeger, 1979. Pp. xii, 255. Cloth. An in-depth analysis of major interest groups and Congress: the way these groups present arguments to Congress; how Congress evaluates these arguments; and what factors condition the final Congressional decision.
- United States Military Intervention: Law and Morality. O'Brien, William Vincent. Beverly Hills: Sage Publications, 1979. Pp. 88. Paper. The author studies the legal and moral problems of military intervention as they arose during the U.S. involvements in the Dominican revolution and the Viet Nam war, and further suggests guidelines for the just and legal conduct of any military interventions in which the U.S. may henceforth engage.
