- The Control of the Sea-bed. Luard, Evan. New York: Taplinger Publishing Co., Inc., 1977. Pp. x, 315. Cloth. A discussion of the issues which have developed regarding the conflict over the sea-bed, and an examination of the solutions that may finally be available.
- Doing Business in Germany. Mueller, Rudolf, Stiefel, Ernst, and Brocher, Horst. Germany: Fritz Knapp Verlag, Frankfurt am Main, 6th ed., 1971. Pp. 156. Cloth. A revision of new German laws and major amendments including the development of judicial and administrative practices for the foreign businessman who wishes to operate or invest in the German Federal Republic.
- The Exclusive Economic Zone. Extavour, Winston Conrad. Geneva: Institut Universitaire de Hautes Etudes Internationales, 1979. Pp. xv, 369. Cloth. A study of the exclusive economic zone, both past and present, and its effect on the development of international law and in particular, the law of the sea.
- Indian Constitutional Law. Jain, M.P. Bombay: N.M. Tripathi Private, Ltd., 3rd ed., 1978. Pp. 746. Cloth. A comprehensive study of the Indian Constitution and latest case law, with comparison to the United States, Canadian, Australian, and British Constitutions.
- Insecurity: The Spread of Weapons in the Indian and Pacific Oceans. O'Neill, Robert, ed. Canberra: Australian National University Press, 1978. Pp. x, 279. Cloth. This book discusses the proliferation of weaponry in the Indian and Pacific Ocean areas, and its impact on the superpowers, the stability of their major subregions, and the security of all nations situated in the area.
- International Courts. Ralston, Jackson Harvey. California: Stanford University Press, 1926. Pp. xi, 512. Cloth. The views of arbitrators upon questions arising under the law of nations and of the procedure and practice of international courts.
