- Anti-Apartheid: Transnational Conflict and Western Policy in the Liberation of South Africa. Shepherd, George W. Jr. Westport, Conn.: Greenwood Press, 1977. Pp. xii, 246. Cloth. This book discusses the role of foreign governmental and economic interests, as well as private international organizations, in the struggle for human rights in South Africa.
- Constitutional and Administrative Law. Phillips, O. Hood and Jackson, Paul. London: Sweet and Maxwell, 6th ed., 1978. Pp. xlx, 746. Cloth. This comprehensive treatise on British constitutional law has been revised to consider recent developments, including human rights legislation and membership in the European Communities.
- Collective Bargaining Rights of Government Employees in Canada. Swartz, Jean W. Ottawa, Ontario: Library of Congress (Canada), 1978. Pp. 32. Paper. An explanation of Canadian federal and provincial legislation authorizing collective bargaining and the right to strike for public employees.
- EEC Competition Law: An Analysis of Recent Decisions and Developments. Beckerleg, Barlo, ed. Oxford, England: E.S.C. Publishing, Ltd., 1978. Pp. 154. Paper. Eight articles by European lawyers discussing recent developments in the antitrust laws of the European Community and their practical application for international businesses.
- The Future of the International Court of Justice. Gross, Leo, ed. Dobbs Ferry, N.Y.: Oceana Publications Inc., 1976. Pp. x, 839. 2 Vol. Cloth. An inquiry into the future of the World Court. Individually authored chapters by members of a Panel on the Future of the International Court of Justice established by the American Society of International Law.
- Indian and English Private International Law. Diwan, Paras. Bombay: N.M. Tripathi Private, Ltd., 1977. Pp. xlvi, 688. Cloth. A treatise on the international aspects of India's civil law, presented throughout by comparison and contrast to English law.
- The International Law of Detente: Arms Control, European Security, and East-West Cooperation. McWhinney, Edward. Alphen aan den Rijn, The Netherlands: Sijthoff & Noordhoff, 1978. Pp. xi, 259. Cloth. A multi-faceted look at the cooperation and tension between the world's two rival political-military blocs.

- The author discusses the philosophical roots of detente, its historical evolution from the Cold War, strategic arms limitation, technological cooperation, and prospects for the future.
- International Law Perspectives of the Developing Countries: The Relationship of Law and Economic Development to Basic Human Rights. Okolie, Charles. New York: N.O.K. Publishers International, Ltd., 1978. Pp. xii, 369. Cloth. This book discusses the influence of aid relationships with industrialized nations on the development of Third World countries. Social and ecological development are contrasted with pure economic growth as desirable goals. Relations with the socialist bloc and the western bloc are compared.
- International Politics and the Sea: The Case of Brazil. Morris, Michael A. Boulder, Colo.: Westview Press, 1979. Pp. xii, 291. Cloth. Brazil's oceans policy is examined as an example of a developing state's position.
- The International Taxation of Multinational Enterprises in Developed Countries. Adams, J.R. and Whalley, J. Westport, Conn.: Greenwood Press, 1977. Pp. 178. Cloth. This book provides an overview of the complex tax situation faced by multinational corporations. It considers the rationales proposed for various tax policies and suggests alternatives.
- The Latent Power of Culture and the International Judge. Prott, Lyndell V. Abington, Australia: Professional Books, 1979. Pp. xxi, 250. Cloth. An analysis of the influence of a judge's national training on the jurisprudence of the International Court where he sits. This book was originally written in German, and uses primarily examples familiar to German-speaking readers. The author attains a transnational perspective in his application of the theories of social psychology to the interaction of differing national influences in an international court.
- Law and Policy in Petroleum Development: Changing Relations Between Transnationals and Governments. Hossain, Kamal. London: Francis Pinter, Ltd., 1978. Pp. xiii, 284. Cloth. A comparative study of the laws and policies of ten diverse countries relating to petroleum development, intended particularly for policy-makers in developing countries.
- Legal Protection of Individuals in the European Communities. Toth, A.G. Amsterdam: North-Holland Publishing Company, 1978.

- Pp. xxi, 226, 372. 2 Vol. Cloth. Examines the status of individual rights of citizens of the European Communities, and discusses remedies and procedures available to enforce these rights in the European Court of Justice and the national courts.
- Patent Licensing in Europe. Cawthra, B.I. London: Butterworths, 1978. Pp. xix, 256. Cloth. Legal constraints in the European Economic Community on the licensing of patented technology, with commentary on clauses likely to be found in patent licensing agreements.
- Protecting the Human Environment: Procedures and Principles for Preventing and Resolving International Controversies. Levin, Aida Luisa. New York: United Nations Institute for Training and Research, 1977. Pp. xiii, 131. Paper. A discussion of the range of procedures available for the settlement of international disputes concerning environmental matters, with examples of their application.
- The Reform of Family Law in Europe. Chloros, A.G., ed. Deventer, The Netherlands: Kluwer B.V., 1978. Pp. ix, 349. Cloth. A collection of thirteen articles treating the current status of family law in Europe, noting particularly the equality of spouses, divorce, and the status of illegitimate children.
- Resource Management at the International Level: The Case of the North Pacific. Young, Oran. London: Francis Pinter, Ltd., 1977. Pp. 252. Cloth. A theoretical study of the maintenance of environmental quality at the international level, analyzing the marine areas in the vicinity of the Bering Strait as an example.
- Search For Justice: Neighborhood Courts in Allende's Chile. Spence, Jack. Boulder, Colo.: Westview Press, 1979. Pp. xi, 206. Cloth. During a period of political upheaval in the early 1970's, two kinds of neighborhood courts emerged to serve the urban poor in Chile. This book examines instances of each and discusses the potential benefits of such decentralized judicial institutions.
- Soviet Employee's Rights in Law. Glazyrin, V., Nikitinsky, V., Maksimova, N., and Yarho, A. Moscow: Progress Publishers, 1978. Pp. 208. Cloth. This book attempts to present a detailed understanding of Soviet labor legislation and its effect on young people to the foreigner.

- The Tax/Benefit Position of Selected Income Groups in OECD Member Countries—Report by the Committee on Fiscal Affairs. Paris: Organization for Economic Co-operation and Development, 1978. Pp. 132. Paper. A comparative study of the impact of tax and social welfare programs on various income levels in the twenty-three member countries.
- White Wealth and Black Poverty: American Investments in Southern Africa. Rogers, Barbara. Westport, Conn.: Greenwood Press, 1976. Pp. xv, 331. Cloth. The author scrutinizes the effect of U.S. and multinational investment in minority-ruled countries, the consequences of distribution of economic benefits according to the decisions of the white minority, and criticizes the attempts of U.S. corporations to defend their involvement as a liberalizing influence.
- World Public Order of the Environment: Towards an International Ecological Law and Organization. Schneider, Jan. Toronto: University of Toronto Press, 1979. Pp. xv, 319. Cloth. A framework of inquiry is suggested to clarify and implement an effective international law of the environment. Procedural problems and future policies are examined.
