BOOKS RECEIVED

- The Disputing Process—Law in Ten Societies. Nader, Laura and Todd, H.F., Jr., eds. New York: Columbia University Press, 1978. Pp. xx, 372. Cloth. This book is a compilation of essays dealing with the problems and methods of resolving disputes within various societies.
- The Extension of Corporate Personality in International Law. Ijalaye, David A. Dobbs Ferry, New York: Oceana Publications, Inc., 1978. Pp. xi, 354. Cloth. Mr. Ijalaye's S.J.D. dissertation deals with a distinct problem of public international law: what status should be afforded international organizations under international law? The title expresses the author's position.
- Human Rights in Europe. Robertson, A.H. Manchester, England: Manchester University Press, 1977. Pp. xvii, 329. Cloth. This text provides an account of the 1950 European Convention for the Protection of Human Rights and Fundamental Freedoms. The author initially addresses the rights guaranteed under the Convention and then discusses them in light of the organization and function of the European Commission of Human Rights, the European Court of Human Rights, and the Committee of Ministers of the Council of Europe.
- Human Rights, International Law, and the Helsinki Accord. Buergenthal, Thomas and Hall, Judith R., eds. New Jersey: Allanheld, Osmun & Co. Publishers, Inc., 1977. Pp. viii, 203. Cloth. This book is published under the auspices of the American Society of International Law. The editors compiled essays dealing with the Helsinki Accord and related international legal problems, including human rights and domestic jurisdiction, the international legal obligations of signatories, and the interrelationship of the Helsinki Accord and other international conventions on human rights.
- Law Reform in the Muslim World. Anderson, Norman. London: The Athlone Press, University of London, 1976. Pp. xi, 235. Cloth. This volume deals with recent reforms in Muslim law which were prompted by the "political, economic, and ideological stresses of modern life . . .," and covers such areas as commercial law, criminal law, and family law.
- The Legal Regime of Islands in International Law. Bowett, Derek W. Dobbs Ferry, New York: Oceana Publications, Inc., 1979. Pp. 337. Cloth. Mr. Bowett's treatise describes and defines the legal regime of islands in the context of ocean law and sovereignty claims. He then applies the principles discussed to various re-

- gions including the English Channel, the Southwestern Approaches, the Aegean Sea, the China Sea, and the Gulf of Venezuela.
- A Modern Introduction to International Law. Akehurst, Michael. London: George Allen and Unwin Ltd., 1977. Pp. 283. Cloth. This book provides a concise and general overview of public international law.
- Social Security in Latin America—Pressure Groups, Stratification, and Inequality. Mesa-Lago, Carmelo. Pittsburgh, Pennsylvania: University of Pittsburgh Press, 1978. Pp. xix, 351. Cloth. This book considers the historical development, organization, structure, and the problems confronting the social security systems of various Latin American countries, including Argentina, Chile, Mexico, Peru, and Uruguay.
- The Soviet Procuracy and the Supervision of Administration. Smith, Gordon B. The Netherlands: Sijthoff & Noordhoff International Publishers BV, 1978. Pp. xii, 154. Cloth. This text considers the function of the Soviet procuracy as a mechanism to monitor and control the Soviet administrative process. The author describes the structure and function of the procuracy and how it relates to problems involving the Soviet administrative hierarchy.
