## Books Received

- Commercial Operations in Europe. Goode, R.M. and Simmonds, K.R., eds. Leyden, the Netherlands: A.W. Sijthoff, 1978. Pp. xxvii, 448. Cloth. This is a collection of papers originally presented at the 1977 London International Conference on "Commercial Operations in Europe." Since updated, paper topics include the harmonization of commercial law and implementation of economic freedoms within the EEC, the legal, taxation, and accounting problems of setting-up corporations in community member-countries, and the special considerations which must be given to joint ventures and international sales transactions.
- The European Parliament and the European Community. Herman, Valentine and Lodge, Juliet, New York, N.Y.: St. Martin's Press, Inc., 1978. Pp. 199. Cloth. In this volume the European Parliament is examined in terms of its nature as an elective body, its role within the institutional set-up of the European Community, and its ultimate impact on the citizenry of the Community.
- Guide to the United Nations Organization, Documentation and Publishing. Jainal, Peter I. Dobbs Ferry, New York: Oceana Publication, Inc., 1978. Pp. xxviii, 450. Cloth. This manual serves as an introduction to the complex structure of the United Nations, and provides guidance for efficient research of U.N. documents and publications.
- Glimpses of the Working of Parliament. Shakhder, S.L. New Delhi, India: Metropolitan Book Co. (P)Ltd., 1977, Pp. 396. Cloth. Given the atmosphere of constitutional reform that exists in India at the present time, this study provides a timely appraisal of and insight into the functioning of a parliament which occupies a pre-eminent and pivotal position in the country's constitutional makeup.
- The Impact of International Labour Conventions and Recommendations. International Labor Office (ILO), Geneva, 1976. Pp. vi, 104. Paper. Since the ILO's establishment in 1919, its principal activity of setting international labor standards has become a significant practice in the world community. This publication traces the practical effects of formal, as well as informal standard-setting by the ILO.
- The International and National Protection of Movable Cultural Property. Williams, Sharon A. Dobbs Ferry, New York: Oceana Publications, Inc. 1978. Pp. xvii, 302. Cloth. This is a comprehensive study on the evolution and implementation of the international

legal regime for the protection of cultural property. While acknowledging the contributions of the existing conventions, the author criticizes the latter's failure to uniformly define "cultural property"—a major pitfall to implementation—and offers proposals for reform.

- International Boundary Disputes and International Law. Sharma, Surya P. Bombay, India: N.M. Tripathi (P)Ltd., 1976. Pp. xvi, 323. Cloth. This informative volume focuses on the nature and functions of international boundaries, specific boundary disputes between States, and the examination of those disputes in light of the rules and norms of international law.
- International Telecommunication Agreements. Wallenstein, Gerd D. Dobbs Ferry, New York: Oceana Publications, Inc., 1977. Loose-leaf. This text has two basic purposes: (1) to record the accomplishments of the International Telecommunication Union (ITU), and (2) to elaborate a general-purpose model for voluntary collaboration, based on the ITU's agreement-making system.
- Micronesia Under American Rule—An Evaluation of the Strategic Trusteeship (1947-77). Nufer, Harold F. Hicksville, New York: Exposition Press, Inc., 1978. Pp. 245. Cloth. Heralded as a definitive study of America's role in Micronesia, this in-depth evaluation relies substantially on hundreds of firsthand interviews with American, Micronesian, and Japanese officials, businessmen, and others.
- Organized Labor in Latin America. Spalding, Jr., Hobart A. New York, N.Y.: Harper Torchbooks, 1977. Pp. xv, 297. Paper. This is a compact yet inclusive historical account of the labor movement in Latin America.
- The Soviet Procuracy Protests: 1937-1973. Law in Eastern Europe Series No. 21. Boim, Leon and Morgan, Glenn, comps. Alphen aan den Rijn, the Netherlands: Sijthoff & Noordhoff, 1978. Pp. xvi, 603. Cloth. An enlargement of the Procuracy's role in the Soviet legal system may be discerned from this compilation of over 800 cases of protests and representations lodged by the Procuracy during a period of thirty-five years.
- Studies in International Law. Malawer, Stuart S. Buffalo, New York: William S. Hein & Co., Inc., 1977. Pp. 388. Cloth. A collection of twenty-one essays by the author, covering a broad spectrum of interests for the transnational lawyer.
- The Supreme Court of India. Dhavan, Rajeev. Bombay, India: N.M. Tripathi (P)Ltd., 1977. Pp. 524. Cloth. An exhaustive analysis of the Court's decisions in several areas between 1950 and 1976,

this scholarly work attempts to acquit the Supreme Court of India of political design, at a time when the Court is under attack for usurpation of the powers of judicial review.
