## DEDICATION

Professor Daniel E. Murray was born in Cleveland, Ohio, in 1925. In 1932 Daniel moved with his family to Miami. He has since remained a member of the community, attending St. Theresa's School in Coral Gables until he joined the U.S. Army, where he served with distinction in the European Theatre in World War II.

After leaving the service he returned to Miami and came to the Law School. As a student, his commitment to excellence became evident. He was a member of the Editorial Board of the *Review* (then called the *Quarterly*), he became a charter member of the Phi Delta Phi honorary, and graduated second in his class.

The practice of law lured Dan from academic life, but his successful Miami law practice did not prevent his eventual return to the Law School. In 1957 he joined the University of Miami Law Faculty as an assistant professor. In 1963 he received his S.J.D. from New York University. In 1967 he was awarded a full professorship at Miami.

At the Law School Daniel Murray is respected by his colleagues for his active role in school affairs and continuing scholarly publications. As Chairman of the Academic Affairs Committee he has been a leader in developing academic standards for the School. He is a prolific legal writer, having published fifty-seven articles in over twenty journals. He has written in legal areas as diverse as constitutional law, criminal law, commercial law and domestic relations. This past year he published four articles. During the summers of 1962-1965 he performed a comparative study of criminal law in Spain, Guatemala, Mexico, and Peru under the auspices of a Ford Foundation Fellowship. From this work he became a coeditor of the volume, *The Administration of Criminal Justice*.

Dan Murray is admired by students as a talented teacher and active advisor to the *Law Review*. Recognition came to Daniel Murray for his inspired law teaching in 1968. The School's five-year alumni and the graduating senior class of 1968 voted him the Outstanding Teacher Award. A generation of students have studied law with him and have benefited from his fine teaching. Professor Murray became faculty advisor to the *Review* in 1958. Through his relationship with the writers and editors of the *University of Miami Law Review* he has evidenced his dedication to legal scholarship. Under his guidance the *Review* has broadened its scope from reporting regional events to considering national issues. He has counseled hundreds of young writers in their search for excellence in legal writing and analysis.

The authors of these comments on Daniel Murray have been his colleagues and friends since 1957. They are happy to have been given the opportunity to contribute to this dedication.
